WOOLWICH, MAINE: The BayScribe American Transcription Network (BATN) got another big boost in November when New England Medical Transcription (NEMT) joined the BATN cooperative.

Sullivan said she agreed to join the co-op because NEMT is committed to remaining a 100-percent all-American company.

“Partnering with other like-minded American businesses helps us to leverage the power of thousands of MTs all over the country,” Sullivan said. “By joining together, we can provide exceptional service to the nation's largest hospitals, which might otherwise consider offshoring their jobs to other countries.

She also pointed out that the BayScribe platform will bring new levels of functionality to NEMT’s clients by providing them with mobile dictation applications and Natural Language Processing capabilities.
